(Previous Roof Repairs) Roof replaced in 2022. Information can be provided upon request.

(Previous Other Structural Repairs) Ruptured plumbing pipes resulting from 2021 Winter Storm Uri caused significant water damage to the home. As a result, a comprehensive professionally designed renovation was completed in 2023.

The first floor was taken down to the studs. Repairs and replacements included all interior walls, cabinetry, flooring, countertops, ceilings in the kitchen and living areas, interior doors, plumbing fixtures, and lighting. All electrical boxes, wiring, and panels were replaced. All appliances were replaced. New Pella windows were installed along the rear of the home. Existing water heaters were removed and replaced with a tankless water heating system.

The upstairs also underwent renovation, including replacement of all flooring, painting of walls and doors. The hallway bathroom was remodeled, including new walls, cabinetry, flooring, plumbing, and fixtures. The primary upstairs (en suite) bathroom received new plumbing fixtures, designer shower, flooring, and countertops. Electrical fixtures, lighting, and outlets upstairs were replaced. A new window was installed in the west bedroom; all other upstairs windows were repaired or reworked.

The interior and exterior of the home were repainted in 2022.

Documentation related to the 2023 renovations is available upon request.

(Settling) Normal settling issues only, resolved in renovation. Nothing of structural note.

(Water Damage Not Due to a Flood Event) Busted pipes from Winter Storm Uri followed by complete remediation. Detailed information on remediation available upon request.



(Wood Rot) Normal wood issues all of which repaired or replaced. Exterior of home was extensively repaired at same time of renovation/remediation completed in 2023. Including replacing back exterior wood on first floor with Hardy board fire-resistant siding. Wood frames around upstairs windows replaced.
